



**Emergency Financial Aid Grants to Students Under the  
Coronavirus Response and Relief Supplemental  
Appropriations (CRRSAA) Act**

**PUBLIC DISCLOSURE – January 10, 2022**

The federal stimulus legislation known as the Coronavirus Response and Relief Supplemental Appropriations Act (“CRRSSA), Pub. L. No. 116-260, signed into law by the President on December 27, 2020, includes relief to institutions and students for costs associated with the Coronavirus emergency.

1. New England Tractor Trailer Training Schools of Massachusetts and Connecticut (“NETTTS”) have signed and returned to the ED the Certification and Agreements for the CRRSAA Emergency Financial Aid Grants.
2. The total amount of funds that the institution will receive from the Department pursuant to the institution’s Certification and Agreement for Emergency Student Financial Aid Grants is:

NETTTS of Massachusetts	\$1,217,556

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 314(a)(4) of the CRRSSA as of September 30, 2021 is:

4. The estimated total number of students eligible to receive Emergency Financial Aid Grants to students under Section 314(a)(4) of the CARES Act is:

5. Grants were issued to the student on May 6, 2021. The total number of students who have received an Emergency Financial Aid Grant to students under Section 314(a)(4) of the CARES Act as of March 31, 2021 is:

6. NETTTS used the following method to determine which students would receive Emergency Financial Aid Grants under Section 314(a)(4) of the CRRSAA Act. To be eligible for Emergency Financial Aid Grants, the student:

- A. Must have been enrolled in one of NETTTS' Title IV approved programs (CDL600 or HVACR Technology) prior to March 27, 2020;
- B. Must have been registered as "ACTIVE" status BETWEEN December 27, 2020 and April 16, 2021;
- C. Must be a US citizen or qualified Alien;
- D. Must complete an Application for Emergency Financial Aid Grants to Students Under the CARES Act and present it to the NETTTS financial aid office.

NETTTS used the following method to determine how much Emergency Financial Aid Grant funding students would receive under Section 314(a)(4) of the CRRSAA Act:

- A. NETTTS determined that its Emergency Financial Aid Grant amounts would be based on exceptional need and used the students Expected Family Contribution.

<b>NETTTS OF CT - AWARDING SCHEDULE</b>	
\$1600	EFC of ZERO. This group of students has the most need based on established financial aid formulas. These students were eligible to receive a maximum PELL Grant.
\$1000	EFC 1 – 5711. This group of students has need based on established financial aid formulas. These students were eligible to receive a PELL Grant.
\$750	EFC 5712 – 9999. This group of students has need based on established financial aid formulas, but these students were not eligible to receive a PELL Grant.
\$500	EFC >= 10000 or no ISIR on file. This group of students has need based on established financial aid formulas; however, the need is somewhat less. Also, these students were not eligible to receive a PELL Grant.

<b>NETTTS OF MA - AWARDING SCHEDULE</b>	
<b>ADDITIONAL NEED BASED GRANT</b>	
\$1250	EFC of ZERO. This group of students has the most need based on established financial aid formulas. These students were eligible to receive a maximum PELL Grant.
\$625	EFC 1 – 5711. This group of students has need based on established financial aid formulas. These students were eligible to receive a PELL Grant.
\$3004	EFC 5712 – 9999. This group of students has need based on established financial aid formulas, but these students were not eligible to receive a PELL Grant.
\$200	EFC >= 10000 or no ISIR. This group of students has need based on established financial aid formulas; however, the need is somewhat less. Also, these students were not eligible to receive a PELL Grant.
