## 4. LOAN DEBT INFORMATION

Please note that you must repay money that you borrow as student loans to pay for this program, including interest. # 5. LOAN NONPAYMENT STATISTICS

Each year, the U.S. Department of Education (USDOE) issues an official notice regarding the percentage of former NETTTS students that have defaulted on their Federal student loans. The most recent official three-year notification was issued in September of 2023 and was for USDOE fiscal year 2020. The Federal Cohort Default rate represents the cohort default rate for both the main and branch campus. The data used to calculate default and repayment rates are tracked via the USDOE National Student Loan Data System (NSLDS). Using this data, the following table discloses the most recent rates for former students of the Massachusetts NETTTS campuses listed under Federal ID#02584401.

NETTTS also offers a payment plan to students that may need extra time to pay a remaining balance due after receipt of any financial aid. There is no interest associated with these payment plans. For 2021, 6.86 % of the students on payment plans failed to pay all or a portion of their balance back to the school. This percentage is determined by calculating the number of students who fail to make a payment for over 90 days. Contrary to this, 93.14 % of the students made their payments in a timely manner.
